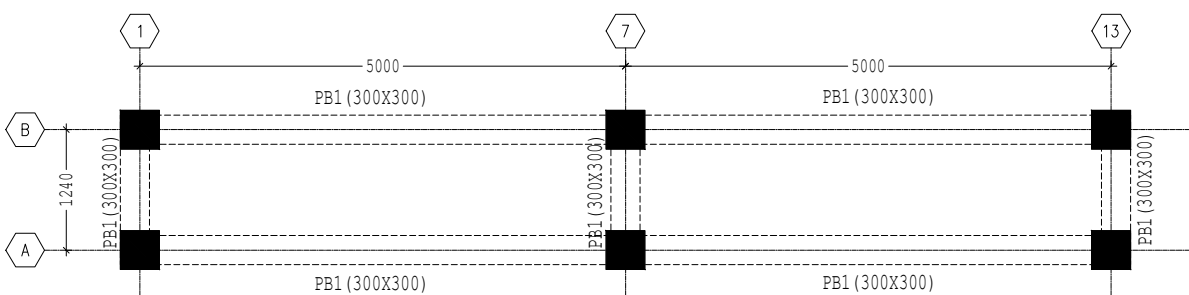
FOUNDATION LAYOUT PLAN



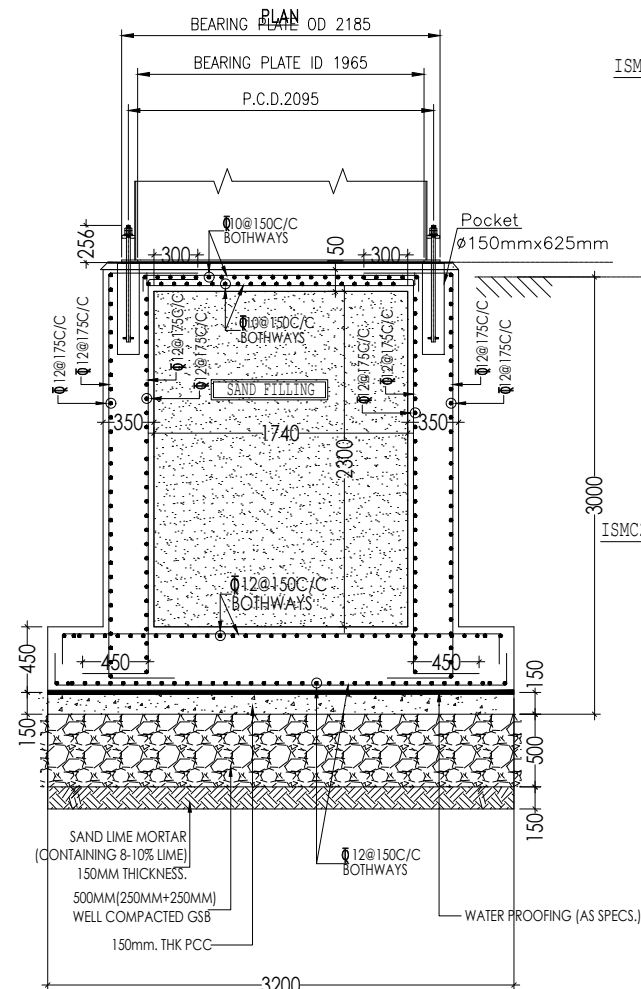
SLAB BEAM FRAMING PLAN



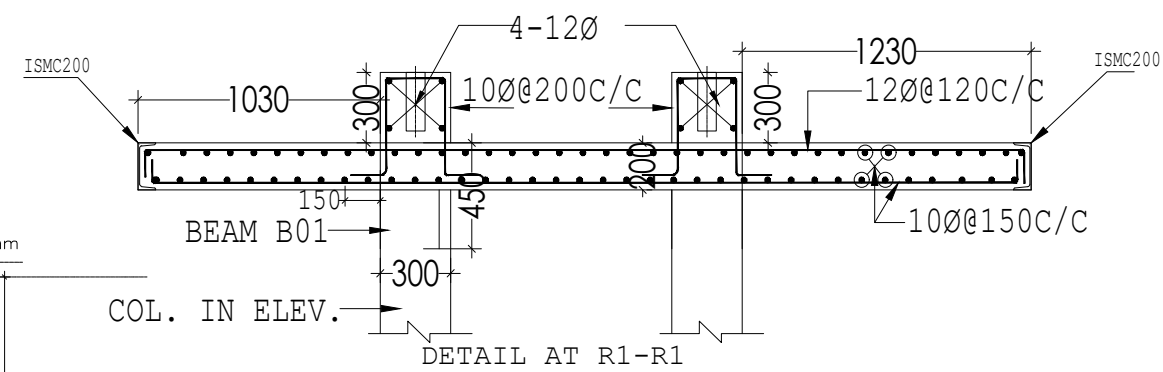

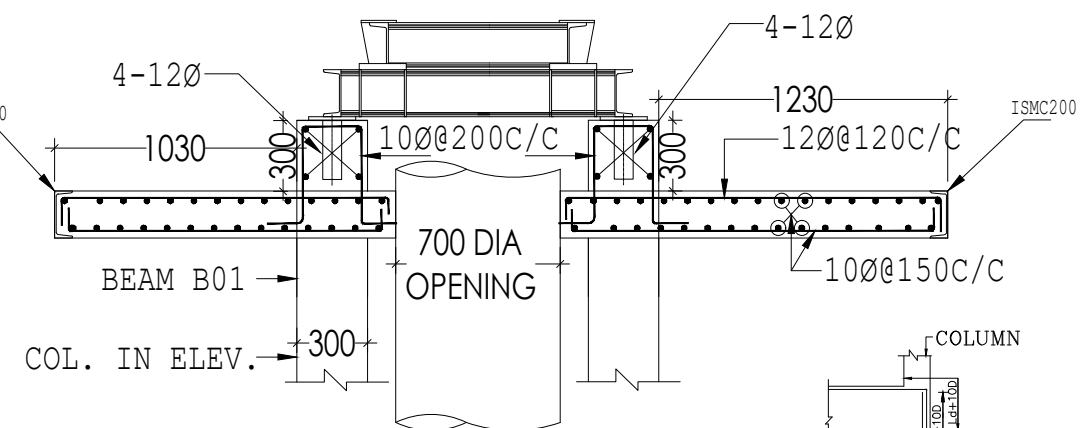
PLINTH BEAM FRAMING PLAN



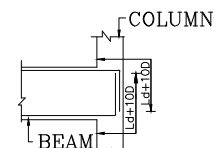
