- d. The bids should be submitted in a sealed cover containing following two separate envelopes:
Technical bid:
1. Technical qualification page along with all the documents mentioned in it.
2. Copy of all the section except section 5 i.e. Price Bid duly signed and stamped on all the pages.
Price bid: Containing the price bid in the form provided in the tender document. No condition other than what already mentioned in the tender documents will be accepted.
- e. The bid shall be submitted through speed post/ register post/ courier or hand delivery. The complete liability to ensure that the bid shall reach in time will be with the bidder. Under no circumstance will allow any allowance for the delay arising out of postal or courier delivery.
- f. VGEL reserves the right to accept or reject any or all tenders in part or full or to cancel the issue of tender documents without assigning any reason whatsoever. Similarly, in the interest of company, company have absolute right to go for retendering without assigning any reason whatsoever to anyone.
- g. Bidder has to accept all terms and conditions unconditionally.

Section 3: Financial Conditions

1. **PRICE:** Price to be quoted by the bidder should be fixed and it should be including all other Taxes Except GST. GST will be paid extra on quoted rate as may be applicable (present prevailing rate). Any changes in GST + / - to be borne by VGEL during the purchase period.
2. **PENALTY / Liquidated Damages:** The Penalty / Liquidated Damages clause will be applicable at the rate of 0.5% of value of Services ordered per week and a ceiling of 5% of the total order value for non-completing work, period to the agreed work completion period. Any delay in Service provide by you should be completed within time limit specify in Section 1 of this tender document. If work will not complete then it may lead to penalty / Liquidated Damages to Contractor.
3. **GUARANTEE / Free maintenance required during work period:** The service provided by you should be guaranteed / maintain for the minimum period of 6 months from the date of supply / Install / Complete the work. Due to any incident natural or manual, you have to repair covering work immediately after our intimation. Inspection & Measurement of Work & material to be done by VGEL Technical team before starting & after completion of work. Contractor has to inform VGEL for the same.
4. **Payment Terms:**
 - (a) 10% amount will be paid as an advance with Work Order.
 - (b) Rent amount will be released per month after completing billing process. Bidders have to raise total bill of actual work measurement.
 - (c) 30% amount will be released in 1 week of July-2022 after completion of work.
 - (d) 15% amount will be released in first week in August-September-October-November 2022.
 - (e) Full GST will be paid with 1st Payment after Invoice.

5. **The Rate should be inclusive of Installation and removal of shed with maintenance during the contract period including the transportation charges of the personnel involved.**

If the bidder backs out after making the offer then VGEL will have right to impose a penalty and forfeit EMD amount along with 5% of the work order amount and the same will be deducted from the pending payments of the bidder. If no payment is pending then the bidder will stand blacklisted and will be allowed to bid in VGEL only after he deposits the penalty amount.
