1. Vapi Green Enviro Limited (VGEL), a Non Equity- Non Profit entity, based on cooperative principles with corporate culture of management, was formed with an objective of providing a Comprehensive Environment Management Program (CEMP) for the estate.
2. VGEL is operating common facilities for the collection, treatment (CETP) and disposal of 55 MLD industrial effluents in the estate of Vapi having approx. membership of 500 industrial units.
3. VGEL is operating Common Solid Waste Plant (CSWP) at GIDC Vapi. Treatment Storage Disposal Facility (TSDF) is developed by VGEL. VGEL have decided for Extension of Solid Waste Cell 1&2 at CSWP Site.

Qualification Criteria For TPQA Agency

1. Bidder should have completed at least one project of costing not less than 60% of estimated cost (i.e. 15.53 crores) as a Third party Inspection agency in any Govt./Semi govt./ or PSU.
2. The firm should have experience of at least Five years as TPQA.
3. Minimum Turnover of agency based or income tax returns during last three years should not be less than 5 % of total Estimated project cost (i.e. Rs. 350 lac)
4. Agency should have its own Laboratory or should have MOU with government approval laboratory.
5. Agency should have sufficient technical staff having experience of similar type of works.

Scope of work for TPQA

- 1) The objective of the work is to provide third party inspection to control on the quality of materials and works with quality assurance of the materials & works by carrying out the quality control tests on the materials & work tests and quality of control work during the execution of the work as per the specification.
- 2) TPQA agency shall check & certify all materials, plants, machineries, equipments tools etc in respect to civil, electrical & mechanical and electronics areas of work.
- 3) To check overall quality of all completed & ongoing works for quality assurance.
- 4) To carry out required test of work carried out and certify the acceptability.
- 5) Testing of procured material batch wise and certify that the material is acceptable or not.
- 6) The TPQA shall ensure that all actions are taken to built in quality insurance in the planning and execution of the work. The quality insurance shall cover all stages of work, such as setting out, selection of materials, selection of construction method, selection of equipment and plant, deployment of personnel and supervisory staff, quality, control, testing etc.

- 7) The TPQA agency shall follow all relevant specifications provided in the contract agreement of the work and also enforce any such relevant specifications not covered therein with due approval of Executive Engineer.
- 8) The TPQA shall in accordance with frequency of testing to be undertaken deploy their qualitative adequate manpower for due inspection at the relevant premises of manufacture and / or work site. (Travelling & other expanses shall be incurred by contractor / manufacture in case of inspection / visit out of Vapi.)
- 9) The TPQA should certify whether the procured material is accepted / rejected as individual or batch wise, as the case may be. However, this certificate shall always be duly supported by documentary test result as evidential justification.
- 10) Testing of samples of the materials brought by contractor at manufacture's laboratories / Govt. approved laboratory. These testing charged shall be paid by contractor.
