Section 3: Financial Conditions

- 1. PRICE: Price to be quoted by the bidder should be fixed and should cover the entire the scope of this work. The price quoted by the bidder to be inclusive of all taxes, levies, duties etc. as may be applicable. Please see section 5 of this tender for more details. Price bids of only technically qualified suppliers will be opened after technical evaluation. Price bid will not be opened in front of all participants, only sealed envelope will be shown before opening.
- 2. <u>PENALTY:</u> The Penalty clause will be applicable at the rate of 0.5% per week and a ceiling of 5% of the total order value for the pending part of work period the agreed completion period. Any delay in work completion may lead to penalty.
- 3. <u>SCHEDULE OF PAYMENT:</u> The payment will become due on VGEL once the bills are completely certified by Technical department. VGEL will make the payment within 30 days.
- **4. SECURITY DEPOSIT**: The amount submitted as EMD may be adjusted as security deposit.
- **5.** <u>Retention Money:</u> 05% retention money to be deducted from each Running bill. 5% Retention money will be released after completion of 1 Year from Payment of Final Invoice.

6. Important Note:

(a) VGEL will provide Epoxy Paint, Oil Paint, Plastic Paint, Distemper, Lime Painting as per requirements. VGEL will also provide Tools of Painting work like Painting Brush, Painting Roller, Scrapping Tools, Wire Brush, Emery Paper, Finish Paper, Hand Gloves Etc.

Contractor will ensure the proper use of Paint and Tools done by Labour. VGEL will issue new tools against submission of old Tools. Minimum wastage of material will be responsibility of Contractor. VGEL may deduct amount is wastage of material done by Contractor.

- (b) Bidders have to provide Rates for each category.
- (C) Empty Tin of Paint should not be taken out side VGEL Site by contractor. It is VGEL property.
- (d) Photography of work place before starting of work and after completion of work is compulsory and it should be submitted to VGEL by contractor.
