## **Section 3: Financial Conditions**

1. **PRICE:** Price to be quoted by the bidder should be fixed during supply period. It can be decrease subject to market fluctuation (Price may be checked in open market on monthly basis). The price quoted by the bidder to be inclusive of all taxes, levies, duties etc. as may be applicable (present prevailing rate). Any changes in Government taxes + / - to be borne by us during the annual rate contract period.
2. **PENALTY / Liquidated Damages:** The Penalty / Liquidated Damages clause will be applicable at the rate of 0.5% of value of material ordered per week and a ceiling of 5% of the total order value for the part of non-supply period the agreed delivery period. Any delay in supplying of material supplied by you should be guaranteed for the period of at least 12 months, material may lead to penalty / Liquidated Damages.
3. **Important Note:**

VGEL will place Purchase order for full Tender quantity at a time. Bidders have to accept it. Purchase Order Rate of Coal will be fixed and binding to bidder for supply of the tender quantity. If coal technical specifications not observed as specified in Tender document, then it will be deducted as mentioned below. VGEL have right to stop supply at any time in case of Coal supply is not as per Purchase order specifications or any other reasons.

Vapi Green Enviro Limited will deduct amount from Invoice of Coal if technical parameters are out of tolerance limit. i.e. Calorific Value, Moisture %, Ash % and Weight Difference on pro-rata basis, Sulphur Content, Sieve Analysis. Bidders are requested to supply material as per technical parameters mentioned in tender documents.

**If Supplied Coal will not be found as per Purchase order Technical Specification, then Vapi Green Enviro Limited will purchase material from Other Bidders for Stop-Gap Arrangement at their Quoted Rate and VGEL will deduct difference amount from L1 Bidders. L1 Bidder have to supply coal as per Purchase order rate of 1<sup>st</sup> PO till completion of Tender Quantity. Please confirm this matter with sign and stamp on Tender document.**

**Lump-Sum 50% of Invoice amount will be deducted as a Penalty in case of Supplied Coal Parameters like Moisture exceed out of Tolerance and observed above 32% Continuously. Deduction of Moisture between 27% to 32% will be done. If Moisture observed above 32% then Lump-Sum 50% Invoice amount will be deducted. Calculation of Deduction for Calorific Value will be done on GCV(ARB) Basis. VGEL may issue Purchase order to more than one bidder at same rate for Continuous Coal Supply.**

4. **SCHEDULE OF PAYMENT:** The payment will become due on VGEL once the material supplied by you is fully accepted by the competent authority as well as bills are completely certified by store & purchases department. VGEL will make the payment within 30 days.
