Section 3: Financial Conditions

1. PRICE:

Price to be quoted by the bidder should be fixed and should cover the entire scope of this supply& Installation that including Accessories, 1 Year Guarantee period, Next 2 year CMC Period, IQ, OQ, PQ, Documentation charges for 3 Years. The price quoted by the bidder to be inclusive of all taxes, levies, duties etc. as may be applicable, as mentioned on Section 5 of this tender document.

2. <u>PENALTY:</u>

The Penalty clause will be applicable for delay supply at the rate of 0.5% per week and a ceiling of 5% of the total order value for the late supply period. Supply period (as per Scection-1) from the date of Purchase Order.

VGEL will deduct penalty amount for delay in supply & Installation work as per above terms.

3. SCHEDULE OF PAYMENT:

Payment will be due from VGEL once the bills are fully certified. VGEL will make the payment within 30 days. Ninety-five percent (95%) of the basic amount plus GST will be paid after the successful supply and installation of the equipment at COE, Vapi. The remaining 5% of the basic amount will be held as retention money and will be released after one year from the date of installation. If the supplier prefers, this 5% payment can be released earlier upon submission of a performance bank guarantee equal to 5% of the order value, valid for one year.

4. GUARANTEE / DEFECT LIABITY PERIOD

The Supply of equipment shall be guaranteed for the soundness and its performance for the period of 12 months from the date of Installation at site. Any defect occurred on account of poor workmanship and MOC shall be attended by the Bidder during guarantee period.

5% Retention Money amount will be released after 12 months from the date of Installation or 18 months from date of supply whichever is earlier.

2 Year free CMC after completion of Guaranty Period should be inclusive with this supply from date of Installation.

5. EMD & Performance Bank Guarantee:

- (a) The EMD of un-successful bidder will be released within 1-2 week from the placement of Purchase order to Successful bidder.
- (b) The EMD can be returned to the successful bidder after installation of Instrument.

6. Delivery Period:

Within 8-10 Week from date of issue of LOI/Purchase Order/Work Order/Agreement, whichever is earlier.

7. <u>Certification & Inspection</u>:

Bidder has to provide all required test certification as applicable at the time of delivery. VGEL will inspect material before dispatch at bidder's site if required. Third party inspection also may be done if required.

8. Installation of the Instrument:

Installation of the Instrument will be Free of Cost and in scope of Supplier. Bidder will arrange supervision and other requirement. Required tools, Tackles, other equipment will be arranged by Bidder. Please specify the details of the same in technical bid.
